3. These animals are individually identified and all animals receiving medication or deemed ineligible for any reason have been identified. Good animal husbandry practices have been followed to provide proper housing, good nutrition, and low stress handling to ensure each animals health and well being has been maintained.
4. I attest that all livestock referenced by this document and transferred are of the U.S.A. origin (i.e. born and raised in the U.S.A.)

The undersigned, previously agreeing to adhere to these rules, confirms that to the best of their knowledge the cattle identified below meet each of the requirements and will cooperate to determine the cause of any problems that might arise that would lend doubt to the eligibility of any of the cattle referenced by this document.
